Notice of Amendment to Declaration of Covenants, Conditions and Restrictions for the Ruby Ranch Subdivision Dated: June 26, 2000

Notice is hereby given that the Declaration of Covenants, Conditions and Restrictions for the Ruby Ranch Subdivision originally approved October, 1979, as amended to August, 1983 and December 1989 is further Amended, pursuant to Article XII, Section 4, thereof in the following particulars:

Article VII, Section 11 is amended to read, in its entirety, as follows

Section 11. <u>No Resubdivision</u>. After June 1, 2000, no lot described on the recorded plat of the subdivision shall ever be resubdivided into smaller tracts or lots nor conveyed nor encumbered in any less than the full original dimensions as shown on said recorded plat.

Article VIII, Section 1 is amended to read, in its entirety, as follows

Section 1. <u>Number and Location of Buildings</u>. No buildings or structures shall be placed, erected, altered, or permitted to remain on any residential lot other than:

- (1) One detached single-family dwelling house containing a minimum of **2000** sq. ft. of finished living area and one smaller apartment-type residential unit not to exceed 1000 square feet of finished living area as an integral part of the dwelling house or of the garage; and
- (2) One attached or detached garage per unit; and
- (3) One barn or stable or other non-residential out-building.

No dwelling house or other structure shall be placed, erected, altered, or permitted to remain on any residential lot at any site or location other than substantially that indicated on the development guide of the subdivision.

These amendments were approved by 47 of the 54 lots comprising the Ruby Ranch subdivision, the ballots therefore being recorded herewith.
